All Members are subject to a \$125 monthly food minimum between April and November each year. To encourage use of this important Club support, 6, 7- or 8-month alternate periods are available for those with shorter summer stays in New England. TERMS

Membership dues at Pleasant Valley are charged annually on January 1. Members paying their 2021 dues by December 31, lock in the Early Pay rate and avoid any increase in 2021, otherwise Members may take up to 3 months to pay without interest. Member account must be current to take advantage of the early pay discount. Account balances after April 1, will be subject to a 1 ½ per month finance charge until payment is received in full. There is no pro-ration of membership dues if you choose to join after April 1. All membership after April 1 are subject to availability based on demand. All 2021 member accounts must have a current credit card on file.
