TERMS

Membership dues at Pleasant Valley are charged annually on January 1. Members paying their 2022 dues by January, 31, 2022 will lock in the Early Pay rates and avoid any increase in 2022, otherwise Members may take up to March 15, 2022 to pay their Full 2022 dues. Member account must be current to take advantage of the early pay discount. Members dues must be paid in full by March 15, 2022 or your roster spot will not be guaranteed. All 2022 member accounts must have a current credit card on file.
